

Privacy Statement

Cotoax grants great importance to protecting your privacy. Your data will be processed and will be carefully secured by us. In this privacy statement, we will explain which personal information we will collect, and its purposes.

Processing of personal data

Cotoax processes your data as you use our services. The only information we will collect are:

- **On Register**
 1. Your submitted name.
 2. Email.
 3. Your salt-hashed password.

- **On Login and Purchase**
 1. Your current IP address.

We are interested in data that provides us with the basic information that we can use on our website, i.e the number of visitors in a certain period, which countries our visitors come from, and which pages have the most views. The information obtained is the property of Cotoax.

Use of personal data

Cotoax collects and uses your data to deliver the information, the services, the services you have requested and to manage the website. We also use your data for research and analysis to improve both our website and our services.

Cotoax needs a legal basis to process your data. Cotoax will process your data based on preparing grounds such as executing an agreement, based on a legal obligation or through your permission. In the case of consent, you have the right to withdraw it at any time.

All of our employees respect your privacy and all personal data and information are treated confidentially.

Transfer to third parties

Cotoax does not sell, rent, or lease its customer lists to third parties. Cotoax will never disclose your data, without notice, except when required by law or in good faith, belief that such action is necessary to:

- comply with a legal request; or
- to protect and defend the rights or property of Cotoax; or
- act under exigent circumstances to protect the personal safety of users of Cotoax or the public.

Storage of personal data

The basic principle for storing personal information is that all data is not stored any longer than necessary. Cotoax will, therefore, not store personal data for longer than is strictly necessary. If the data given is required by law, we are obligated to store it for longer.

Security of personal data

Cotoax ensures appropriate organizational, technical, and physical protection of your data. Cotoax keeps the personal information that you have provided on computer servers that are secured in a controlled and safe environment, protected from unauthorized access, use or disclosure.

Automated decision making

Cotoax does not make decisions based on automated processing about matters that can have (significant) consequences for people.

Your Rights

You are entitled to a range of rights regarding the protection of your Personal Data, which are subject to limitations, restrictions and conditions as laid down in GDPR and applicable law. Those rights are:

- The right to access the information we process about you;
- The right to rectify incorrect/inaccurate information about you;
- The right to transfer all or part of the information collected about you to you or another data controller, where technically feasible (the right to data portability; with limitations and restrictions as specified in the EU General Data Protection Regulation);
- The right to erase any data concerning you. Users may demand erasure of data without undue delay for legitimate reasons, e.g. where data is no longer necessary for the purposes it was collected, or where the data has been unlawfully processed;
- The right to the restriction of data processing. Users, for legitimate purposes, may obtain restriction of data processing from the controller;
- The right to object to the processing of Personal Data when processing is carried out on the basis of legitimate interest, as well as in cases of use of your personal data for direct marketing purposes, as specified above in this Policy.

When you object to processing of Personal Data when processing is carried out on the basis of legitimate interest, we will carefully consider such a request, which may result in your Account closure or de-activation.
